ADDENDUM NO. 3

This ADDENDUM NO. 3 hereby revises the Contract Documents dated December 28, 2022. Revisions made herein shall become a binding part of the Contract Documents.

NOTICE OF PUBLIC HEARING AND LETTING

1) Replace the Notice of Public Hearing and Letting with the Revised Notice of Public Hearing and Letting (Addendum No. 3). The Notice of Public Hearing and Letting has been revised as follow:

Due to inclement weather, the date and time for receiving bids has been moved to February 28th at 11:00 AM.

TECHNICAL SPECIFICATIONS

Section 11936: Vertical Turbine Pumps

- 2) Page 11936-04: Replace Paragraph 2.02.E.2 as follows:
 - 2. Head shall be fabricated steel, ASTM A53, Grade B or high-grade cast-iron ASTM A48, Class 30.
 - a. Suitable for mounting driver and supporting pump column, bowls, and dynamic loads.
 - b. The discharge head shall be aesthetically compatible with the mounted motor and with adjacent pumping units. Where the motor is different in dimension than the discharge pipe,

a plate shall be provided to transition between the two masses.

3) Page 11936-06: Revise Paragraph 2.07 as follows:

Max Motor Horsepower	60 HP

This ADDENDUM NO. $\underline{3}$ shall become a legal and binding part of the Contract Documents. All BIDDERS shall acknowledge receipt of this ADDENDUM NO. $\underline{3}$ on the BID FORM and agree to accept the revisions indicated and prepare proposals in accordance therewith.

NOTICE OF PUBLIC HEARING AND LETTING

Lewis and Clark Connection Sheldon, Iowa (ADDENDUM NO. 3)

Sealed proposals for the Project will be received by the City of Sheldon, Sioux and O'Brien Counties, Iowa, at the Council Chambers located in the Community Services Center at 416 9th Street, Sheldon, Iowa 51201 until 11:00 A.M. on the 28th day of February 2023, for the Lewis and Clark Connection Project as described in the Plans and Specifications therefore now on file in the office of the City Clerk.

Proposals will be opened by representatives of said City at a meeting to be held at the Council Chambers, on the day and hour above specified. At $\underline{4:30}$ P.M., on the $\underline{1^{\text{st}}}$ day of March 2023, at said place, the proposals will be considered by the City Council of said City. A hearing will also be held on the proposed form of Contract and estimate of cost for said Lewis and Clark Connection.

The extent of the WORK involved consists generally of:

Modification to an existing water treatment plant. The project includes site piping, process piping, pumps, motors, electrical, control integration, and miscellaneous appurtenant work.

All WORK and materials are to be in strict compliance with DRAWINGS and SPECIFICATIONS prepared by DGR Engineering, Rock Rapids, Iowa, Engineer, which, together with the proposed form of CONTRACT and ESTIMATE OF COST have heretofore been approved by the City and are now on file for public examination in the Council Chambers in said City of Sheldon, are by this reference made a part hereof as though fully set out and incorporated herein.

All BIDS must be filed in said office on or before the time herein set on forms furnished by the Owner and must be enclosed in a separate sealed envelope and plainly identified. Each BID shall be accompanied by a BID BOND, certified check, cashier's check, or certified credit union share draft in a separate sealed envelope in an amount equal to ten per cent (10%) of the total amount of the BID. If BID BOND is submitted, it must be on the form provided with the CONTRACT DOCUMENTS. The certified check, cashier's check, or certified credit union share draft shall be drawn on a bank in Iowa, a bank chartered under the laws of the United States of America, or said certified share draft shall be drawn on a credit union in Iowa or chartered under the laws of the United States and payable to the Treasurer of the OWNER as security that if awarded a contract, the BIDDER will enter into a contract at the prices BID and furnish the required PERFORMANCE and PAYMENT BONDS and Certificate of Insurance. The certified check, cashier's check, or certified share draft may be cashed, or the BID BOND forfeited, and the proceeds retained as liquidated damages if the BIDDER fails to execute a contract or file acceptable PERFORMANCE and PAYMENT BONDS or provide an acceptable Certificate of Insurance within ten (10) days after the acceptance of said BID by resolution of the City. No BIDDER may withdraw a BID within thirty-five (35) days after the date set for opening BIDS.

Payment of the said WORK will be made in cash. Payment will be made in monthly estimates and one final payment. Payment for the WORK completed during the preceding calendar month will be determined by the Engineer pursuant to the GENERAL CONDITIONS and in accordance with

the provisions of Chapter 573 Code of Iowa. Upon acceptance by the OWNER, the final payment will be issued on the balance found to be due the CONTRACTOR, including the retained percentages, but except such sums as may be lawfully retained by the OWNER, and shall not be paid to the CONTRACTOR no earlier than thirty-one (31) days after the OWNER'S Final Acceptance of the WORK.

The WORK under the CONTRACT shall commence on or before the date specified in a written NOTICE TO PROCEED and shall be substantially completed and ready for operation by <u>October 1, 20</u>23.

By virtue of statutory authority, preference will be given to products and provisions grown and coal produced within the State of Iowa and to Iowa domestic labor to the extent lawfully required under Iowa statutes; provided, however, that the Board may award such CONTRACT as it deems to be in the best interests of the District, which shall be without regard to such factors. The Owner will, in evaluating Bids, consider the requirements of the resident bidder preference law, and allow such preferences to resident bidders as are required to be allowed under State Law. Bidder shall, when submitting a Bid, furnish an executed Bidder Status Form for the Owner to use when applying the preference law. Failure to submit a fully completed Bidder Status Form with the bid may result in the bid being deemed nonresponsive and rejected.

The successful Bidder shall be required to meet Federal requirements outlined in the bid documents, award documents, construction documents, supplemental conditions, and other contract forms.

Out-of-state contractors (as defined by Section 103A.3 of the current Iowa Code), before commencing a contract in excess of \$5,000 in value in Iowa, shall file a bond with the office of the Division of Labor Services of the Department of Employment Services in accordance with Section 91C.7 of the current Code of Iowa.
