RULES & REGULATIONS FOR USE OF THE SHELDON OUTDOOR FAMILY AQUATIC CENTER

1. The applicant shall be responsible for any damage to equipment or property. If, after any activity additional janitorial maintenance is required, other than the normal cleaning process, the applicant may be charged accordingly.
2. Activities for minors must be supervised by responsible adults.
3. The posted pool rules must be followed at all times during the course of the activity. The group must also follow the directions of the lifeguard on duty during the course of the scheduled activity.
4. The Recreation Director may reserve the right to cancel the activities at any time if it seems necessary.
5. No alcoholic beverages, No smoking, No drugs or anyone under the influence of alcohol or drugs will be allowed on the premises at any time.
6. You're allowed to bring your own non-alcoholic drinks (No Glass) and food. We just ask that you clean up any messes during rental.
7. No glass objects are allowed at the Sheldon Outdoor Aquatic Center.
8. If there's a weather condition and we are forced to cancel your rental you will have the option to reschedule or will be refunded in full. However, any rental that last at least 50% of the time rented, will not receive a refund.
